AGENCY UPDATES REQUIRED

America's Water Infrastructure Act



The 2025/2026 cycle marks the second round of America's Water Infrastructure Act (AWIA), requiring small, medium and large water systems serving populations greater than 3,300 people to update their Risk and Resilience Assessments and Emergency Response Plans. The following summarizes key impacts to the water industry.

WATER INFASTRUCTURE AND **INNOVATION ACT**

The Water Infrastructure Finance and Innovation Act of 2014 (WIFIA) established a federal credit program administered by the EPA for eligible water and wastewater infrastructure projects. It defines borrower criteria, including government entities, partnerships, corporations, trusts, and SRF programs. WIFIA funds diverse projects like Clean Water and Drinking Water SRF, energy efficiency, desalination, and more.

FUNDING ASSISTANCE

COMMUNITY WATER SYSTEM RISK AND RESILIENCE

The legislation requires communities with water systems serving populations great than 3,300 people to assess risks to and resiliency of its systems relative to malevolent acts and natural hazards, infrastructure and cybersecurity, financial infrastructure, chemicals and chemical systems, system operations and maintenance, and capital and operational needs for risk and resilience system management.

EMERGENCY RESPONSE PLAN

Water systems serving populations greater than 3,300 people are required to prepare or revise their emergency response plans through a risk and resiliency assessment. Plans should incorporate findings of the assessments and include plans to improve system reliance. This includes detecting malevolent acts and natural hazards; physical security and system cybersecurity; critical equipment and actions, procedures, and equipment that significantly can reduce emergency impacts.
